1 AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTION 4.50.030A.  
2 TO CHANGE THE TERMS OF THE BUDGET ADVISORY COMMISSION.

5 THE ANCHORAGE ASSEMBLY ORDAINS:  
6

7 **Section 1.** Anchorage Municipal Code section 4.50.030A. is hereby amended to read as  
8 follows (*the remainder of the section is not affected and therefore not set out*):  
9

10 **4.50.030** **Budget Advisory Commission.**  
11

12 A. There is established a municipal budget advisory commission consisting of  
13 nine members.

- 14 1. Terms shall commence on July 1 and end at midnight on June 30,  
15 except as to members appointed to fill an unexpired term.  
16 2. In order to provide for an orderly transition, all existing terms on the  
17 date of this amendment shall be shortened by three and one-half  
18 months, expiring on June 30 of the appropriate year, instead of October  
19 14, as originally appointed and confirmed.  
20 3. The municipality shall provide sufficient secretarial and other staff  
21 assistance as needed by the commission.

3 **Subject:** An Ordinance Amending Anchorage Municipal Code Section 4.50.030A to Change  
4 the Terms of the Budget Advisory Commission.

7 Current municipal code specifies that Title 4 Board and Commission members, with the exception of  
8 one body, are appointed to three year terms beginning on October 15 and ending October 14. While this  
9 cycle fits well with mayoral inauguration and other seasonal needs, it does not mesh well with the  
10 Municipal Budget preparation and adoption cycle. At the request of the Budget Advisory Commission  
11 and with the concurrence of Office of Management and Budget staff, this ordinance would change the  
12 cycle for the Budget Advisory Commission to terms beginning earlier in the year, on July 1 and ending  
13 on June 30. The BAC passed resolution 2007-03 supporting a change to have terms end August 15, but  
14 the administration's suggested cycle is consistent with the intent and BAC's request for an earlier term  
15 date to accommodate the budget review process. Besides affecting new appointees, it would shorten the  
16 terms for sitting members by three and a half months.
