8 THE ANCHORAGE ASSEMBLY ORDAINS:

10 **Section 1.** Anchorage Municipal Code section 4.50.020 is hereby amended to read as
11 follows (*the remainder of the section is not affected and therefore not set out*):

13 **4.50.020 Bidding Review Board.**
14

15 There is established a bidding review board consisting of nine members including:
16

- 17 A. One member from the board of building regulation examiners and
18 appeals;
19 B. One member from the municipal light and power utility
20 commission;
21 C. One member from the public facilities advisory commission;
22 D. One member from the Anchorage Water and Wastewater Utility
23 Authority Board of Directors [WATER UTILITY COMMISSION];
24 E. One member from the port commission; and
25 F. Four members from the construction and labor industry.

10 The Municipal Assembly created the Anchorage Water and Wastewater Utility (AWWU) Authority
11 by passing AO 2005-107. This single piece of legislation addressed multiple facets of the transition
12 to an authority. However, it overlooked a reference in municipal code to the former AWWU
13 Advisory Commission in Title 4 that governs the composition of the Bidding Review Board. This
14 ordinance updates the composition of the Bidding Review Board by clarifying that a member of the
15 AWWU Authority Board of Directors shall sit on the Bidding Review Board as appointed by the
16 mayor and confirmed by the Assembly.
