ANCHORAGE, ALASKA AO NO. 2008–40

AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AMENDING ANCHORAGE MUNICIPAL CODE SECTION 2.30.050, INTRODUCTION OF ORDINANCES; ACTION ON ORDINANCES, TO REPEAL THE PROVISION FOR AUTOMATIC DEFEAT WITHOUT A VOTE OF THE ASSEMBLY.

THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1.</u> Anchorage Municipal Code section 2.30.050, is hereby amended by repealing subsection 2.30.050F as indicated. (*Other subsections are not affected and therefore not set out*):

[F.] [AFTER PUBLIC HEARING ON AN ORDINANCE HAS BEEN COMPLETED, THE VOTE ON THE ORDINANCE MAY BE CONTINUED NO MORE THAN TWO TIMES AND FOR A TOTAL PERIOD OF NOT MORE THAN FOUR REGULARLY SCHEDULED MEETINGS. IF NO VOTE ON THE ORDINANCE OCCURS PRIOR TO THE END OF THE FOUR REGULARLY SCHEDULED MEETINGS PERIOD, THE ORDINANCE SHALL BE AUTOMATICALLY DEFEATED WITHOUT A VOTE. THE PROVISIONS OF THIS SUBSECTION MAY BE WAIVED BY A MAJORITY VOTE OF THE ASSEMBLY TAKEN PRIOR TO THE EXPIRATION OF THE FOUR REGULARLY SCHEDULED MEETINGS PERIOD.]

Subject: AO 2008-40 — AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AMENDING ANCHORAGE MUNICIPAL CODE SECTION 2.30.050, INTRODUCTION OF ORDINANCES; ACTION ON ORDINANCES, TO REPEAL THE PROVISION FOR AUTOMATIC DEFEAT WITHOUT A VOTE OF THE ASSEMBLY.

Anchorage Municipal Code Subsection 2.30.050F has been cumbersome to administer since its adoption in January 2004. In review of the recent judicial decision in *Stuart v. Municipality of Anchorage*, Case No. 3AN-07-4155 CI, with the Municipal Attorney's Office and the Municipal Clerk, it is clear that our understanding of the application of the code provision in Anchorage Municipal Code Subsection 2.30.050F and the Superior Court's differ.

From the perspective of the Municipal Clerk, there is sufficient agenda control in place without the application of Subsection 2.30.050F jeopardizing Assembly action when items remain in active status to accommodate Assembly Work Session schedules and additional review.

In summary, we feel Subsection 2.30.050F is unnecessary. AO 2008-40 is an ordinance to repeal this subsection. No other changes to AMC Section 2.30.050 are proposed.
