AN ORDINANCE SETTING THE RATE OF TAX LEVY, APPROVING THE  
AMOUNT OF MUNICIPAL PROPERTY TAX, AND LEVYING TAXES FOR THE  
ANCHORAGE SCHOOL DISTRICT FOR TAX YEAR 2008

THE ANCHORAGE ASSEMBLY ORDAINS:

**Section 1.** The Assembly hereby fixes the rate of tax levy for the Anchorage School District for tax year 2008. The Anchorage Assembly levies this tax upon the full value of all assessed taxable real and personal property, as follows:

Areawide Schools a tax of 6.94 mills

**Section 2.** The property tax amount approved for 2008 (within the meaning of the tax increase limitation ("tax cap") provision of the Charter, Section 14.03) is:


Anchorage School District \$212,165,785

3 SUBJECT: AN ORDINANCE SETTING THE RATE OF TAX LEVY, APPROVING

9 This memorandum transmits the ordinance to establish the 2008 tax rate and tax levy for  
10 the Anchorage School District. The Anchorage School District (ASD) tax rate and tax  
11 levy are based on the amount of property taxes required to support the ASD operating  
12 budget in calendar year 2008. These reflect one half of the property taxes required for  
13 ASD's revised fiscal year 2007-2008 operating budget, and one half of the property taxes  
14 required for ASD's fiscal year 2008-2009 operating budget.

16 The property tax shown in AO 2008-55 reflects ASD's revised debt service requirements  
17 for FY 2008-2009 based on voter approval on April 1, 2008 of two education-related  
18 general obligation bond propositions (see AR 2008-63 and accompanying memorandum  
19 AM 216-2008).

21 THE ADMINISTRATION RECOMMENDS APPROVAL OF THE ORDINANCE  
22 SETTING THE RATE OF TAX LEVY, APPROVING THE AMOUNT OF MUNICIPAL  
23 PROPERTY TAX, AND LEVYING TAXES FOR THE ANCHORAGE SCHOOL
