WHEREAS, the Municipality of Anchorage owns property described as Lot 1A, Block 2, Kruse Industrial, King Street O&M Facility; and

WHEREAS, AMC section 25.10.050 states that the Mayor may in writing designate any municipal agency as the managing authority of a specific parcel of municipal property; and

WHEREAS, Land management authority for this property was designated to Anchorage Water and Wastewater Utility (AWWU) in September of 1987; and

WHEREAS, Triple B Corporation is currently at this location under revocable land use agreement between AWWU and Triple B Corporation; and

WHEREAS, AMC section 25.30.020 states that disposal of Municipal land or interest therein shall be by ordinance only; and

WHEREAS, AMC section 25.30.040 states that, notwithstanding exceptions, all disposals of municipal land shall be for fair market value of the interest disposed of, and the municipality may accept in exchange for municipal land any consideration of sufficient value not prohibited by law; and

WHEREAS, at its May 7, 2008 meeting, the AWWU Authority Board supported Triple B Corporation's request for lease privileges within MOA-AWWU property; now therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:


<u>Section 1.</u> AWWU is authorized to lease ground space on a portion of Lot 1A, Block 2, Kruse Industrial; to Triple B Corporation, upon the terms and conditions summarized in the Assembly Memorandum submitted to the Assembly with this ordinance.

Section 2. The lease shall be for a term of five years with three five year renewal periods, subject to mutual consent of both parties. The annual lease payment for each of the years for the first five years shall be \$3,840.
