**Subject:** A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING EIGHTY ONE THOUSAND TWO HUNDRED FIFTY DOLLARS (\$81,250) IN MISCELLANEOUS DONATIONS TO THE MISCELLANEOUS OPERATING GRANTS FUND (261), ANCHORAGE FIRE DEPARTMENT, FOR THE PURCHASE OF EMERGENCY RESPONSE AND FIRE PREVENTION GOODS AND SERVICES.

Over the past four years the Anchorage Fire Department has received a number of private donations, both undesignated and designated, to facilitate the department's efforts to obtain emergency response equipment and perform fire prevention public education services. Major corporate contributors over this period include: the Alaska Regional Hospital Auxiliary (\$26,000.00); Fireman's Fund Insurance Company (\$22,934.00); American Legion, Aurora Borealis Post 21 (\$12,000.00); Wal-Mart/Sam's Club (\$8,700.00); State Farm Insurance Company (\$5,000.00); and the Coalition for Fire Rescue Technologies, Inc. (\$2,249.52).

The remaining \$4,366.48 in miscellaneous contributions include other private party donations and contributions made in lieu of paying fines due for seat belt use infractions.

The employees of the Anchorage Fire Department are very appreciative of the continuing support provided to the department through the many private contributions it receives from the business community and private individuals.
