13 citizens and for persons with disabilities within the Municipality of Anchorage.

15 **Section 2.** That these funds are appropriated to the State Grants Fund (231),
16 Department of Public Transportation.



Subject: APPROPRIATION OF THIRTY-EIGHT THOUSAND ONE HUNDRED FIFTY-SIX DOLLARS (\$38,156) TO THE STATE GRANTS FUND (231), FROM U.S. DEPARTMENT OF TRANSPORTATION THROUGH THE ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES TO ASSIST IN THE FUNDING OF COORDINATED TRANSPORTATION SERVICES FOR SENIOR CITIZENS AND PERSONS WITH DISABILITIES WITHIN THE MUNICIPALITY OF ANCHORAGE

The purpose of this memorandum is to ask for Assembly approval for the Municipality of Anchorage to accept a grant funding senior and ADA transportation. The Municipality of Anchorage received a grant award notification from the Alaska Department of Transportation and Public Facilities. The grant is in the amount of \$38,156 and covers the period of July 1, 2007 through June 30, 2008. This Federal Transit Administration Section 5310 grant through the Alaska Department of Transportation and Public Facilities assists in the funding of the AnchorRIDES, a coordinated transportation service for Anchorage's senior citizens and individuals with disabilities. The required match of \$3,787, is provided through contractual paratransit services, and it will be provided as 'in-kind' matching to this grant from the 2007 and 2008 Operating Budget of the Public Transportation Department.
