NEIGHBORHOODS FOR THE FAIRVIEW HISTORIC SURVEY.

The attached Assembly Resolution appropriates Ten Thousand Two Hundred Forty Nine Dollars and Ninety Two Cents (\$10,249.92) from the State of Alaska through the State Historic Preservation Officer to fund the Fairview Historic Survey. Buildings older than 50 years old are potentially eligible for the National Historic Register and must be evaluated before federal funds may alter them. The lack of a comprehensive historic survey in Fairview has hindered program administrators when pursuing projects in that area. The purpose of the survey is to identify buildings older than 45 years old that may be eligible for the National Historic Register.

These funds represent amendment two on the previously awarded Twenty Four Thousand Five Hundred and Ninety Three Dollars (\$24,593) through AR 2006-119 and AR 2007-236. These funds will reduce Community Development Block Grant funds already designated for this purpose in the Housing and Community Development Consolidated Plan's 2006 Action Plan. A match of at least \$27,376.58 is required to secure the grant. CDBG funds already designated for the Fairview Historic Survey will be used to meet the match requirement.
