Subject: Appropriation of FIFTY TWO THOUSAND DOLLARS (\$52,000) as a grant from the Rasmuson Foundation to the Areawide General CIP Fund (401), Office of Economic and Community Development, for the Girdwood Community Center and Library project.

The attached resolution appropriates \$52,000 as the third installment of a grant from the Rasmuson Foundation for the new Girdwood Community Center and Library. In November 2006, the Rasmuson Foundation approved a grant of \$514,449 for furniture, fixtures and equipment for the Library. Of this total, \$314,449 was awarded initially and was appropriated on January 23, 2007 (AR2007-11). The remaining \$200,000 was subject to a 2:1 local match. Of the match portion, \$148,000 has been received and was appropriated October 9, 2007 (AR2007-210). The present appropriation is the final installment of the grant. \$110,000 in local matching funds has been raised.

In 1995, the Anchorage Assembly adopted the Girdwood Area Plan that identified the development of a joint-use, multi-purpose community center as a community goal. It also identified the need for a re-located library and community center as "immediate" in the implementation schedule for the Plan. The new 9,394 square foot addition to the existing fire hall will provide for a 2,534 square foot community meeting room, a 3,938 square foot public library, and a 396 square foot office space for the Girdwood Board of Supervisors. There will also be a large common space area and retrofits to the fire hall.
