A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING EIGHT THOUSAND SEVEN HUNDRED SEVENTY-NINE DOLLARS (\$8,779) TO THE AREAWIDE GENERAL CIP FUND (401), NINE THOUSAND TWO HUNDRED NINE DOLLARS (\$9,209) TO THE ANCHORAGE FIRE SERVICE AREA CIP FUND (431), SEVENTY EIGHT THOUSAND ONE HUNDRED FORTY DOLLARS (\$78,140) TO THE ANCHORAGE ROADS AND DRAINAGE SERVICE AREA CIP FUND (441), FOUR THOUSAND FIVE HUNDRED SEVENTY-TWO DOLLARS (\$4,572) TO THE ANCHORAGE PARKS AND RECREATION SERVICE AREA CIP FUND (461), AND ONE THOUSAND SIX HUNDRED FORTY-SIX DOLLARS (\$1,646) TO THE PUBLIC TRANSPORTATION CIP FUND (485) OF GENERAL OBLIGATION SERIES "C" BOND PREMIUM FOR THE PAYMENT OF BOND ISSUANCE COSTS.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of \$8,779 be appropriated to the Areawide General CIP fund (401) as General Obligation Series "C" bond premium for payment of bond issuance costs.

Section 2. That the sum of \$9,209 be appropriated to the Anchorage Fire Service Area CIP fund (431) as General Obligation Series "C" bond premium for payment of bond issuance costs.

Section 3. That the sum of \$78,140 be appropriated to the Anchorage Roads and Drainage Service Area CIP fund (441) as General Obligation Series "C" bond premium for payment of bond issuance costs.

<u>Section 4.</u> That the sum of \$4,572 be appropriated to the Anchorage Parks and Recreation Service Area CIP fund (461) as General Obligation Series "C" bond premium for payment of bond issuance costs.

<u>Section 5</u>. That the sum of \$1,646 be appropriated to the Public Transportation CIP fund (485) as General Obligation Series "C" bond premium for payment of bond issuance costs.

Section 6. This Resolution is effective immediately upon passage and approval.

Subject: Appropriating \$102,346 of bond premium related to General Obligation

Series C bonds.

The purpose of this Assembly Resolution is to appropriate the bond premium relating to the General Obligation Series "C" bonds for payment of bond issuance costs. Bond issuance costs are recognized in the Service Area CIP funds based upon the relative percentage of bond proceeds allocated to each Service Area CIP fund. The bond premium is allocated and appropriated to each Service Area CIP fund on a dollar for dollar basis against recognized bond issuance costs. Any remaining bond premium is allocated to the associated general funds to be used for debt service obligations.
