11 **Section 1.** That a sum of Eleven Thousand Eight Hundred Thirty-four Dollars (\$11,834)  
12 is hereby appropriated from the Alaska Department of Transportation and Public  
13 Facilities to assist in the funding of coordinated transportation services for senior  
14 citizens and for persons with disabilities within the Municipality of Anchorage.

16 **Section 2.** That these funds are appropriated to the State Categorical Grants Fund  
17 (231), Department of Public Transportation.

19 **Section 3.** This resolution shall take effect immediately upon passage and approval.

11 The purpose of this memorandum is to ask for Assembly approval for the Municipality  
12 of Anchorage to accept a grant funding senior and ADA transportation. The Municipality  
13 of Anchorage received a grant award notification from the Alaska Department of  
14 Transportation and Public Facilities. The grant is in the amount of \$11,834 and covers  
15 the period of July 1, 2007 through November 30, 2008. This Federal Transit  
16 Administration Section 5310 grant through the Alaska Department of Transportation  
17 and Public Facilities assists in the funding of the AnchorRIDES, a coordinated  
18 transportation service for Anchorage's senior citizens and individuals with disabilities.  
19 The required match of \$1,176 is provided through contractual paratransit services, and  
20 it will be provided as 'in-kind' matching to this grant from the 2007 and 2008 Operating  
21 Budget of the Public Transportation Department.
