10 THE ANCHORAGE ASSEMBLY RESOLVES:

12 Section 1. That EIGHTY FOUR THOUSAND EIGHT HUNDRED EIGHTY EIGHT DOLLARS
13 (\$84,888), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to
14 the State Categorical Grants Fund (231), Anchorage Police Department, for Seat Belt Enforcement.

16 Section 2. That ONE THOUSAND FIVE HUNDRED SEVENTY ONE DOLLARS (\$1,571) is
17 appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2008 Anchorage Police
18 Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage
19 Police Department.



Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Seat Belt Enforcement Program Grant and local match required. (\$86,459)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$84,888 for a Seat Belt Enforcement program. This grant is intended to support focused enforcement during the period April 1, 2008 through September 30, 2008.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of seat belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of Seat Belt Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$1,571, which has been budgeted in the 2008 Police Operating Budget. This grant begins on April 1, 2008 and will end on September 30, 2008.
