Subject: Appropriation of State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management State Homeland Security Reallocated FY2006 Law Enforcement Terrorism Prevention Program Grant (\$10,108)

The Municipality of Anchorage, Anchorage Police Department has received from the Office for Domestic Preparedness through the State of Alaska, reallocated grant funding to enhance security and preparedness for terrorist prevention. This funding has been reallocated from other jurisdictions that were not able to expend the full amount of their original grant allocation. The original FY2006 local award of \$972,806 has been increased to \$982,733. Appropriation of grant and required local matching funds is requested to the State Categorical Grants Fund (231).

Grant funds awarded provide for the procurement of specialized tactical ballistic protection helmets to be utilized by the Anchorage Police Department.

Reallocated FY2006 Law Enforcement Terrorism Prevention Program Grant funds will be administered by the Anchorage Police Department. A special condition of this grant is that the department contribute funds to support associated indirect grant costs. The total projected municipal cost is \$181 which is funded through a 2008 operating contribution from the Anchorage Metropolitan Police Service Area Fund (151). This grant began on September 1, 2006 and will end on March 31, 2008.
