IMPROVEMENT PROGRAM (CIP) FUND (431) TO PAY THE COSTS OF FIRE PROTECTION
CAPITAL IMPROVEMENT PROJECTS

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That THREE MILLION SIX HUNDRED TWENTY TWO THOUSAND DOLLARS
(\$3,622,000) of general obligation bond proceeds of the Municipality of Anchorage are
appropriated to the Anchorage Fire Service Area CIP Fund (431) for the purpose of providing fire
protection capital improvements and related capital improvements within the Anchorage Fire
Service Area as approved by voters in the election held April 1, 2008.

Section 2. That this resolution shall take effect immediately upon passage and approval.

SUBJECT: A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THREE MILLION SIX HUNDRED TWENTY TWO THOUSAND DOLLARS (\$3,622,000) OF GENERAL OBLIGATION BOND PROCEEDS TO THE ANCHORAGE FIRE SERVICE AREA CAPITAL IMPROVEMENT PROGRAM (CIP) FUND (431) TO PAY THE COSTS OF FIRE PROTECTION CAPITAL IMPROVEMENT PROJECTS

On February 12, 2008 the Anchorage Assembly approved an ordinance authorizing a general obligation bond proposition (AO 2008-21, AM 66-2008) for the purpose of providing fire protection capital improvements and related capital improvements within the Anchorage Fire Service Area.

On April 1, 2008, voters approved the bond proposition for Anchorage Fire Service Area in the amount of \$3,622,000. The bond provides funding for Anchorage Fire Training Facility and Replacement Self-Contained Breathing Apparatus in the Anchorage Fire Service Area. The attached resolution appropriates voter-approved bond funds so that work on projects may begin.
