THE ANCHORAGE ASSEMBLY RESOLVES:


**Section 1.** That TWO MILLION DOLLARS (\$2,000,000) of general obligation bond proceeds  
of the Municipality of Anchorage are appropriated to the Anchorage Parks and Recreation  
Service Area CIP Fund (461) to improve swimming pools and related capital improvements  
within the Anchorage Parks and Recreation Service Area as approved by voters in the  
general election held April 1, 2008.

**Section 2.** That this resolution shall take effect immediately upon passage and approval.

On January 29, 2008 the Anchorage Assembly approved an ordinance authorizing an Anchorage Parks and Recreation Service Area bond proposition (AO 2007-148(S), AM 34-2008) for the purpose of paying the costs to repair and upgrade swimming pools, and related capital improvements within the Anchorage Parks and Recreation Service Area.

On April 1, 2008, voters approved the bond proposition for Anchorage Parks and Recreation Service Area in the amount of \$2,000,000. The attached resolution appropriates voter-approved bond funds so that work on projects may begin.
