**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS
TEMPORARY NON-OBJECTION TO TRANSFER OF RESTAURANT EATING PLACE
LICENSE #4523 FROM THE CURRENT LICENSEE, ARMIDA E & JOSE HERNANDEZ,
D/B/A SIMON'S TACO RICO, LOCATED AT 2409 C STREET, TO LICENSEE KHALED
AZZEM, D/B/A SAHARA RESTAURANT, LOCATED AT 2409 C STREET.**

WHEREAS, the current owners of Restaurant Eating Place License # 4523 are Armida E & Jose Hernandez, 5800 Craig Drive, Anchorage, Alaska 99504, d/b/a Simon's Taco Rico, located at 2409 C Street; and

WHEREAS, Khaled Azzem, 2601 Mona Avenue, Anchorage, Alaska 99516, d/b/a Sahara Restaurant, located at 2409 C Street, has made application and paid the required fee for a Transfer of Restaurant Eating Place License #4523 with the Alcoholic Beverage Control Board; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on April 28, 2008, and has determined that the last day for the Assembly to protest transfer of Restaurant Eating Place License #4523 is June 30, 2008; and

WHEREAS, the requisite research and Assembly protest review process will proceed and this matter will be scheduled for public hearing; and

WHEREAS, the owners of Sahara Restaurant wish to use Restaurant Eating Place License #4523 immediately, prior to public hearing before the Assembly and elapse of the sixty-day protest deadline;

NOW, THEREFORE, the Anchorage Assembly RESOLVES:

Section 1. The Anchorage Assembly hereby states its temporary non-objection to transfer of Restaurant Eating Place License #4523 from its current owners Armida E. & Jose Hernandez, d/b/a Simon's Taco Rico at 2409 C Street, to Khaled Azzem, d/b/a Sahara Restaurant at 2409 C Street; and

Section 2. The Anchorage Assembly hereby reserves final action on the application until public hearing is completed, within the protest period. This temporary non-objection shall not be used to bind the Assembly to any future action on the transfer of this liquor license, including without limitation, final action by the Assembly on the application to transfer ownership of Restaurant Eating Place License #4523 within the protest period.

1 Section 3. A copy of this resolution may be presented to the Alcoholic Beverage
2 Control Board as proof that the Anchorage Assembly, as the local governing body, has stated
3 its temporary non-objection to the transfer of Restaurant Eating Place License #4523, in
4 order to permit the Director of the Alcoholic Beverage Control Board to issue temporary
5 approval of the license.
