A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING EIGHTY THOUSAND DOLLARS (\$80,000) AS A DONATION FROM THE RASMUSON FOUNDATION AND VARIOUS GRANTS AND PARK DONORS THROUGH THE ANCHORAGE PARK FOUNDATION TO THE MUNICIPALITY OF ANCHORAGE MISCELLANEOUS OPERATING GRANTS FUND (261) FOR THE PURPOSE OF FUNDING THE ANCHORAGE PARKS AND RECREATION YOUTH EMPLOYMENT IN PARKS PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of Eighty Thousand Dollars (\$80,000) is hereby appropriated as a donation from the Rasmuson Foundation and Park Donors through the Anchorage Park Foundation to the Municipality of Anchorage Miscellaneous Operating Grants Fund (261) for the purpose of funding the Anchorage Parks and Recreation Youth Employment in Parks program.

Section 2. That this Resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.
