A RESOLUTION CONFIRMING THE ASSESSMENT ROLL AND LEVYING SPECIAL ASSESSMENTS FOR SERVICES ON PROPERTY SPECIALLY BENEFITED IN THE DOWNTOWN BUSINESS IMPROVEMENT DISTRICT, SPECIAL ASSESSMENT DISTRICT 1SD97, SETTING THE DATES OF ASSESSMENT, AND PROVIDING FOR ASSESSMENT BILLING, PAYMENT DUE DATES, APPLICATION OF PAYMENTS, DELINQUENCY, PENALTIES, INTEREST AND COSTS FOR DELINQUENCY AND ENFORCEMENT AND APPROPRIATING THE SUM OF SEVENTY ONE THOUSAND FOUR HUNDRED FORTY THREE DOLLARS (\$71,443) IN ASSESSMENT REVENUES WHEN TENDERED TO SPECIAL ASSESSMENT FUND 271 FOR SERVICES BENEFITING THE PROPERTY OWNERS IN SPECIAL ASSESSMENT DISTRICT 1SD97

THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:

Section 1. The services authorized in Anchorage Ordinance No. 2000-98 extending the Downtown Business Improvement District, Special Assessment District 1SD97, (herein "Services") are hereby levied against the properties, lots and tracts specially benefited as set forth in the attached Assessment Roll for Special Assessment District 1SD97 (herein the "Assessment Roll").

Section 2. Timely notice was sent to each property owner whose property is specially benefited by the Services as indicated on the Assessment Roll, and each property owner was given notice of a public hearing before the Assembly for the purpose of providing property owners an opportunity to present objections to the Assessment Roll by showing errors and inequalities and by submitting any reason for amending or correcting the Assessment Roll for Special Assessment District 1SD97.

Section 3. In conformity with the notice to the property owners, the Assembly held a hearing on **AR No. 2008-112** to hear objections by affected property owners to the Assessment Roll. At said hearing, all errors and inequalities to which valid objections were raised, if any, were corrected and the assessed properties and assessment amounts now indicated on the Assessment Roll are and shall be the assessed properties and the annual assessment amounts finally determined to be the properties and assessment and that assessment amounts are fairly proportionate to the special benefit to each property accruing from the services to be provided in Special Assessment District 1SD97. The Assessment Roll has been duly certified by the Clerk. Special assessments are hereby levied

1 against the properties, lots and tracts specially benefited by the said services as
2 set forth in the attached Assessment Roll.

4 **Section 4.** The Municipal Treasurer shall mail, postage prepaid, an assessment
5 bill to each property owner shown on the Assessment Roll in accordance with
6 Anchorage Ordinance No. 2000-98. Assessments shall be due, payable and
7 delinquent, shall bear penalties, interest and costs and the application of
8 payments on and enforcement of assessments shall be as prescribed in
9 Anchorage Ordinance No. 2000-98.

11 **Section 5.** The Assessment Roll hereby established may be recorded with the
12 District Recorder for the Anchorage Recording District, Third Judicial District,
13 State of Alaska as appended hereto or showing only the property description and
14 amount of assessment without the names of the property owners.

15
16 **Section 6.** That the sum of Seventy One Thousand Four Hundred Forty Three
17 Dollars (\$71,443) of Special Assessment District 1SD97 assessment revenues is
18 hereby appropriated to Fund 271 for payment of services benefiting the property
19 owners of said assessment district.

SUBJECT: AR 2008-112; CONFIRMING THE ASSESSMENT ROLL AND LEVYING SPECIAL ASSESSMENTS WITHIN ASSESSMENT DISTRICT 1SD97, THE DOWNTOWN BUSINESS IMPROVEMENT DISTRICT AND APPROPRIATING SEVENTY ONE THOUSAND FOUR HUNDRED FORTY THREE DOLLARS (\$71,443) OF SPECIAL ASSESSMENT REVENUE TO FUND 271 FOR SPECIAL ASSESSMENT DISTRICT 1SD97.

On June 20, 2000, the Municipal Assembly approved Ordinance AO 2000-98, extending the Downtown Business Improvement District, Special Assessment District 1SD97.

AO 2000-98 established Special Assessment District 1SD97 for the provision of public services that are in addition to regular Municipal services as authorized under Anchorage Municipal Code section 19.10.020A.2. These services do not reduce or eliminate services otherwise provided by the Municipality.

With adoption of AO 2007-133(S-1) (as amended), adopting and appropriating funds for the 2008 General Government Operating Budget, Section 8, Line 11 appropriated the sum of \$711,000 of anticipated revenues for 2008 services benefiting property owners within Special Assessment District 1SD97. The Assessment Roll attached totals \$782,443. The attached resolution appropriates the difference between \$711,000 already appropriated and the Assessment Roll total of \$782,443, for an additional appropriation of \$71,443.

AR 2008-112 confirms the 2008 assessment roll for the Downtown Business Improvement District and appropriates funds from assessments to provide services in 2008.

The supplemental services that may be provided include:

- Maintenance, repair and upkeep of public capital improvements located in the areas of the Business Improvement District;
- Maintenance, snow removal, dust suppression, cleaning, beautification, and decoration of public parks, places and pedestrian and vehicular rights-of-way;
- Visitor and tourism services;
- Security services, but not including law enforcement services;

- Promotion of the Business Improvement District and public events within the district; and
- Other closely similar public services that promote the vitality, stability and improvement of the Business Improvement District.

Assessments are calculated upon the basis of real property tax valuation for the tax year 2008. The assessment rate is 1.5 mills up to and including \$10,000,000 plus \$100 per \$1,000,000 of assessed value in excess of \$10,000,000.

Public and Property Owner Notices

In accordance with AMC 19.20.090, by June 30 a written notice of the public hearing was sent first-class mail to each owner of property to be assessed within the boundaries of the district, at the last known address, providing each owner:

- summary of the service,
- designation of the addressee's property to be assessed,
- purpose of the public hearing,
- amount of estimated or actual assessment or maximum millage rate against the property, and
- time and place fixed for the public hearing.

Each notice shall generally inform the property owner of the manner and method of protesting or objecting to the action to be taken at the public hearing.

Notice of the public hearing will be published in a newspaper of general circulation in the municipality at least once a week for two consecutive weeks prior to the time fixed for the hearing, including the following information:

- a summary of the improvement or service,
- the designation of the properties to be assessed in the special assessment district,
- the purpose of the public hearing, and
- the time and place fixed for the public hearing.
