The Municipality of Anchorage has additional grant funding from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$43,262 for increased DUI .08 Impaired Driving Enforcement patrols. This grant is intended to support additional focused enforcement during the period April 1, 2008 through September 30, 2008.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage.
