10 THE ANCHORAGE ASSEMBLY RESOLVES:

12 Section 1. That FORTY THREE THOUSAND TWO HUNDRED SIXTY TWO DOLLARS
13 (\$43,262), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to
14 the State Categorical Grants Fund (231), Anchorage Police Department, for Increased Impaired Driving
15 Enforcement.

17 Section 2. That EIGHT HUNDRED DOLLARS (\$800) is appropriated from the Anchorage
18 Metropolitan Police Service Area Fund (151), 2008 Anchorage Police Department Operating Budget as a
19 contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

21 Section 3. This resolution shall take effect immediately upon passage and approval by the
22 Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of increased Impaired Driving Enforcement Program Grant funding and Local match required. (\$44,062)

The Municipality of Anchorage has additional grant funding from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$43,262 for increased DUI .08 Impaired Driving Enforcement patrols. This grant is intended to support additional focused enforcement during the period April 1, 2008 through September 30, 2008.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$800, which has been budgeted in the 2008 Police Operating Budget. This grant begins on April 1, 2008 and will end on September 30, 2008.
