

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1: That the sum of Sixty Thousand Two Hundred Ten Dollars (\$60,210) is appropriated from within the Girdwood Fire Apparatus Capital Improvement Fund (406) for the purchase of new fire apparatus.

Section 2: That this Resolution shall become effective immediately upon passage and approval by the Anchorage Municipal Assembly.

Annually, the Girdwood Board of Supervisors approves an operating budget appropriation of mill levy revenues as a contribution towards the purchase of new fire apparatus. For budget year 2007, a total of \$60,210 was transferred as revenue to the Girdwood Fire Apparatus Capital Improvement Fund (406). The attached resolution appropriates the contributed revenue from within Fund 406 so that it may be expended for the capital purchase of new fire apparatus.
