Section 29.45.240 (a) of the Alaska Statutes states in part, "The rate of levy, the date of equalization, and the date when taxes become delinquent shall be fixed by resolution." AMC 12.15.060 (A) (1) provides that "Any installment shall become delinquent on the first business day following the tax installment due date."

The Municipal Code grants a seven-day grace period after the tax due date before any penalty is added to the tax. Tax bills are mailed to owners of record 30 days before the due date.

The attached resolution establishes the due dates for payment of first and second installments for the 2008 personal property taxes as August 31, 2008 and October 31, 2008, respectively, and the delinquent dates as September 1, 2008 and November 1, 2008 respectively.
