Subject: APPROPRIATION OF FIFTY THOUSAND DOLLARS (\$50,000) FROM THE ANCHORAGE SCHOOL DISTRICT (ASD) TO THE MISCELLANEOUS OPERATIONAL GRANTS FUND (261) FOR THE COVENANT HOUSE YOUTH RECEPTION CENTER PROGRAM IN THE DEPARTMENT OF HEALTH AND HUMAN SERVICES.

The Department of Health and Human Services has received a contribution from the ASD to partially fund a grant to continue the Youth Reception Center (YRC) program in calendar year 2008.

Since 2005, this program has been a joint project of the Mayor's Office and ASD. This year each party is contributing \$50,000 to the calendar year 2008 budget. The portion of funding contributed by the Mayor's Office has already been approved as part of the 2008 operating budget.

The YRC provides a safe place for youth, who are in the custody of the Anchorage Police Department, to stay until they can be released to a responsible adult or until other arrangements can be made. Children participating in this program are youth who are not required to be held at McLaughlin Youth Center. Services are provided 24 hours a day, seven days a week and include an intake assessment, contacting responsible adults for pick-up of youth, development of action plans, and referrals to other relevant social services. The program aims to address the reasons youth are in custody and provides follow-up services to encourage positive outcomes.

The program is continuing operations under a grant agreement approved by the Assembly (AM 27-2008).
