A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING EIGHTY NINE DOLLARS (\$89) AS A GRANT FROM THE STATE OF ALASKA, DEPARTMENT OF MILITARY AND VETERANS AFFAIRS, DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT AND APPROPRIATING ONE DOLLAR (\$1) AS A CONTRIBUTION FROM THE 2008 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231), ANCHORAGE POLICE DEPARTMENT, FOR THE PURCHASE OF TERRORISM RESPONSE AND PREVENTION EQUIPMENT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of EIGHTY NINE DOLLARS (\$89) is appropriated as a grant from the State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management to the State Categorical Grants Fund (231), Anchorage Police Department, for the purchase of terrorism response and prevention equipment.

Section 2. That the sum of ONE DOLLAR (\$1) is appropriated from the 2008 Anchorage Police Operating Budget, Anchorage Metropolitan Police Service Area Fund (151) as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department, to support the purchase of terrorism response and prevention equipment.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**Subject:** Appropriation of State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management State Homeland Security Reallocated FY2006 Law Enforcement Terrorism Prevention Program Grant (\$90)

The Municipality of Anchorage, Anchorage Police Department has received from the Office for Domestic Preparedness through the State of Alaska, reallocated grant funding to enhance security and preparedness for terrorist prevention. This funding has been reallocated from other jurisdictions that were not able to expend the full amount of their original grant allocation. Appropriation of grant and required local matching funds is requested to the State Categorical Grants Fund (231).

Grant funds awarded provide additional funding for the procurement of specialized tactical ballistic protection helmets and shields to be utilized by the Anchorage Police Department.

Reallocated FY2006 Law Enforcement Terrorism Prevention Program Grant funds will be administered by the Anchorage Police Department. A special condition of this grant is that the department contribute funds to support associated indirect grant costs. The total projected municipal cost is \$1 which is funded through a 2008 operating contribution from the Anchorage Metropolitan Police Service Area Fund (151). This grant began on June 2, 2008 and will end on September 30, 2008.
