

SUBJECT: APPROPRIATION OF SIXTY-FOUR THOUSAND NINE HUNDRED FIFTY-SEVEN DOLLARS (\$64,957) FROM THE STATE OF ALASKA, DEPARTMENT OF EDUCATION, DIVISION OF STATE LIBRARIES TO THE OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT, STATE GRANTS FUND (231), FOR 800# INTERLIBRARY LOAN AND REFERENCE BACKUP SERVICES FOR THE LIBRARY

Notification has been received that the Anchorage Public Library will be awarded a grant by the State of Alaska, Department of Education, Division of Libraries, for the purpose of funding the 800# Interlibrary Loan and Reference Backup Services (\$64,957).

The 800# Interlibrary Loan and Reference Backup Services grant continues funding to provide toll-free interlibrary loan handling services for Alaska's public libraries, school/community libraries and qualified school districts. It also provides continuation funding for backup reference service to all public and school/community libraries in Alaska, and qualified school districts. These grant funds cover the grant period of July 1, 2008 through June 30, 2009.
