
THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That FIFTY THOUSAND SIXTY-FOUR DOLLARS (\$50,064), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Seat Belt Enforcement.


Section 2. That NINE HUNDRED TWENTY-FIVE DOLLARS (\$925) is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2008 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**Subject:** Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Seat Belt Enforcement Program Grant and local match required (\$50,989)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$50,064 for a Seat Belt Enforcement program. This grant is intended to support focused enforcement during the period October 1, 2008 through December 31, 2008.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of seat belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of Seat Belt Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$925, which has been budgeted in the 2008 Police Operating Budget. This grant begins on October 1, 2008 and will end on December 31, 2008.
