The Municipality of Anchorage has received a grant from the Department of Justice, Community Capacity Development Office, through the Russian Jack Weed & Seed Site Office for a Weed & Seed Coordination Program, The Russian Jack Weed & Seed Site Office has received a federal grant to reduce the occurrence of violent and drug related criminal activities in the subject area. One of the identified problems sought to be addressed by this pass-through grant is the infrequency of prioritized sworn officer patrols in this relative high crime area.

Jack Weed & Seed Site Office and Contribution of Local Match (\$50,924)

This grant funding will be used to reimburse sworn officer overtime up to 430 hours immediately through October 15, 2008, to provide confidential funds and to provide necessary surveillance video equipment. This grant will provide increased, focused overtime patrol efforts to reduce gun violence and illegal drug operations in the Russian Jack program site area. The increased presence of patrol officers in and around these targeted housing areas will deter violent or drug related criminal activities while offering the residents an increased sense of security and safety.

A condition of receiving this grant is that the department provides matching funds. The total projected Municipal cost is \$924, which has been budgeted in the 2008 Police Operating Budget.

This grant is being presented after the actual program start date due to a late notification from the Department of Justice. This grant began August, 2008 and will end on October 15, 2008.
