Team Training Conference Grant and local match required (\$29,119)

The Municipality of Anchorage has received a grant from the Alaska Mental Health Trust Authority for attendance at the National Crisis Intervention Team Conference. This is an annual training conference designed to increase the knowledge of mental health disorders and skills for facilitating positive interactions between law enforcement and persons with mental health disorders.

This grant funding will be used to reimburse travel, lodging and training costs for up to sixteen officers of the Anchorage Police Department to attend the 2008 National Crisis Intervention Team Conference this year. Through increased law enforcement awareness of issues associated with mental illness, citizens residing in the Municipality of Anchorage will experience a safer living environment.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$12,799, which has been budgeted in the 2008 Police Operating Budget. The Alaska Police Standards Council will reimburse the department for up to \$4,000 of this cost. This conference will take place in Atlanta, Georgia, beginning November 4, 2008 and ending on November 6, 2008. This grant is being presented after the actual performance begin date of August 15, 2008 due to late notification by the grantor. The grant will end on December 31, 2008.
