
THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That FIFTY-FIVE THOUSAND TWO HUNDRED THREE DOLLARS (\$55,203), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Law Enforcement Equipment.



That FORTY-FIVE THOUSAND EIGHT HUNDRED TWENTY DOLLARS (\$45,820), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2008 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department, for Traffic Enforcement Overtime.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**Subject:** Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Law Enforcement Equipment Program Grant and local match required (\$101,023)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$55,203 for a Law Enforcement Equipment program. The awarded grant funding is intended to enable the purchase of six laser radar units with desktop server and one traffic accident evidence mapping system.

A special condition of this grant is that the department provides matching funds for overtime enforcement of traffic violations. The total projected Municipal cost is \$45,820, which has been budgeted in the 2008 Police Department Operating Budget. This grant begins on October 1, 2008 and will end on September 30, 2009. Through increased awareness and enforcement of traffic violations and the additional deployed traffic enforcement equipment, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.
