That the sum of Twenty Thousand Eight Hundred Ninety-Two Dollars (\$20,892) is appropriated as a contribution from the 2008 General Government Operating Budget, Department of Health and Human Services Areawide General Fund (101) to the Federal Categorical Grants Fund (241) for the Pathways to Sobriety IV Project in the Department of Health and Human Services.

This appropriation will provide the funding necessary to bridge treatment resistant and high frequency users of the emergency alcohol services system into appropriate detoxification and treatment services through the Pathways to Sobriety IV Project. The period of this grant is from September 30, 2008 through September 29, 2009.

Pathways to Sobriety IV will provide case management services for chronic public inebriates through an integrated system of care. Outreach efforts to other community agencies that offer appropriate services and resources to coordinate care include: detoxification programs, substance abuse treatment services, and short term and permanent housing options.

Project funding consists of the \$383,187 grant funds, \$20,892 Municipal matching funds and \$48,427 Municipal in-kind funds for a total project budget of \$452,506.
