A RESOLUTION APPROPRIATING TWO HUNDRED EIGHTY-FOUR THOUSAND FIVE HUNDRED THIRTY-SIX DOLLARS (\$284,536) AS A GRANT FROM THE STATE OF ALASKA, DEPARTMENT OF MILITARY AND VETERANS AFFAIRS, DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT, TO THE ANCHORAGE PARKS AND RECREATION SERVICE AREA CIP FUND (461) FOR THE BEN BOEKE SEISMIC RETROFIT PROJECT

WHEREAS, the Maintenance and Operations Department is responsible for maintenance, preservation and safe operation of Municipal facilities; and

WHEREAS, Two Hundred Eighty-Four Thousand Five Hundred Thirty-Six Dollars (\$284,536) have been offered as a grant from the State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management, for the Ben Boeke Seismic Retrofit project.

NOW, THEREFORE, the Anchorage Assembly resolves:

Section 1. That Two Hundred Eighty-Four Thousand Five Hundred Thirty-Six Dollars (\$284,536) is hereby appropriated to the Anchorage Parks and Recreation Service Area CIP (Fund 461) for the Ben Boeke Seismic Retrofit project as a grant from the State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management.

Section 2. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

The attached Assembly Resolution appropriates \$284,536, as a grant from the State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management, under the Hazard Mitigation Grant Program for the Ben Boeke Seismic Retrofit project. Overhead costs are not allowed by the grant terms. Those costs will come from the Anchorage Parks and Recreation Service Area CIP (461).

The grant agreement has been executed by the State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management and the Municipality of Anchorage, effective May 5, 2008. The grant completion date is November 30, 2009.

The scope of work includes installation of seismic joint and shear wall reinforcements for improved resistance to seismic forces. The work will be accomplished by private contractors under the direct supervision of the Maintenance and Operations Department, Contract Management Section.
