Program Grant and Contribution of Local Match (\$1,479,452)

The Municipality of Anchorage, Office of Emergency Management has received from the Office for Domestic Preparedness through the State of Alaska, FY2008 SHSP grant funding to enhance security and preparedness for terrorist prevention. Appropriation of grant and required local matching funds is requested to the Areawide General CIP Fund (401).

Grant funds awarded will provide for the purchase of additional specialized terrorism response equipment for multiple municipal departments, as follows:

AWARN Mobile & Portable Radios (Anchorage Police Department)	\$ 478,988
AWARN Mobile & Portable Radios (Office of Emergency Management)	299,625
SWAT/EOD Team Specialty Equipment (Anchorage Police Department)	295,400

Intergovernmental Costs (Local Match Portion)	55,439
Total Program Grant Expenditures	\$1,479,452

FY2008 State Homeland Security Program Grant funds will be administered by the Municipal Manager Department, Office of Emergency Management. A special condition of this grant is that the department contribute funds to support associated indirect grant costs. The total projected municipal cost is \$55,439 which is funded through contributions from the Anchorage Areawide Operating Fund (101) and the Anchorage Metropolitan Police Service Area Fund (151). This grant began on October 1, 2008 and will end on December 31, 2010.
