A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TEN THOUSAND TWO HUNDRED FORTY FIVE DOLLARS (\$10,245) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES AND FOUR THOUSAND FIVE HUNDRED EIGHTY FIVE DOLLARS (\$4,585) AS A CONTRIBUTION FROM THE 2008 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR THIS CRASH DATA RETRIEVAL SYSTEM TRAIN THE TRAINER AND CONFERENCE PROGRAM GRANT

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That TEN THOUSAND TWO HUNDRED FORTY FIVE DOLLARS (\$10,245), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for a Crash Data Retrieval System Train the Trainer and Conference Program.

Section 2. That FOUR THOUSAND FIVE HUNDRED EIGHTY FIVE DOLLARS (\$4,585), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2008 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Crash Data Retrieval (CDR) System Train the Trainer and Conference Program Grant and local match required (\$14,830)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a CDR System Train the Trainer and Conference program. This grant will be used for three Fatality Accident Investigation officers to attend the Advanced CDR System Train the Trainer Program and Annual CDR Conference during the period January 25, 2009 through January 30, 2009.

This grant will be used to reimburse travel and training costs related to the Advanced CDR System Train the Trainer Course and Annual CDR Conference to be held in Las Vegas, Nevada. This advanced training will allow three officers to become certified CDR System trainers to enable the local training of additional sworn personnel in the use of the CDR System. With this training, additional officers will be able to utilize this system to obtain critical vehicle information prior to and after a crash. This training will enable a better understanding of how traffic collisions have occurred and how to preserve data for evidentiary value.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$4,585, which has been budgeted in the 2008 Police Operating Budget. This grant began on October 28, 2008 and will end on January 30, 2009.
