**A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THREE THOUSAND TWO HUNDRED SIXTY-TWO DOLLARS (\$3,262) FROM THE STATE OF ALASKA, DEPARTMENT OF NATURAL RESOURCES, DIVISION OF PARKS AND APPROPRIATING TWO THOUSAND FOUR HUNDRED FORTY DOLLARS (\$2,440) AS A CONTRIBUTION FROM THE OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT, HISTORIC PRESERVATION FUND (740), TO THE OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT, STATE CATEGORICAL GRANTS FUND (231) TO SEND ANCHORAGE'S HISTORIC PRESERVATION OFFICER TO THE NATIONAL HISTORIC PRESERVATION COMMISSIONS FORUM IN NEW ORLEANS**

WHEREAS, With the proposed Knik Arm Crossing and Highway to Highway Projects, and other large scale projects with potential impacts on Anchorage's Historic and Cultural Resources, it is important for the Municipality to facilitate training for the Anchorage's Historic Preservation Officer; and

WHEREAS, The State of Alaska has offered the Department of Economic and Community Development a grant for attendance to the 2008 Historic Preservation Commissions Forum held in New Orleans the week of July 9<sup>th</sup> thru the 14<sup>th</sup>, 2008; and

WHEREAS, Funding for this grant is 60% Federal funds passed thru the State of Alaska, Department of Natural Resources, Division of Parks with a 40% match by the Municipality of Anchorage, Historic Preservation Fund, for a total of \$5,702; now, therefore;

THE ANCHORAGE ASSEMBLY RESOLVES:

**Section 1.** That Three Thousand Two Hundred Sixty-Two Dollars (\$3,262) is hereby appropriated as a Federal Pass Through Grant from the State of Alaska, Department of Natural Resources, Division of Parks to the Office of Economic and Community Development, State Categorical Grant Fund (231) to send Anchorage's Historic Preservation Officer to the National Historic Preservation Commissions Forum held in New Orleans, July 9-14, 2008.


**Section 2.** That Two Thousand Four Hundred Forty Dollars (\$2,440) is a contribution from the Historic Preservation Fund (740), to the Office of Economic and Community Development, State Categorical Grants Fund (231) as a required match to attend the National Historic Preservation Commissions Forum.

**Section 3.** This resolution shall be effective immediately upon passage and approval by the Assembly.

The State of Alaska has offered the Department of Economic and Community Development a grant for attendance to the 2008 Historic Preservation Commissions Forum held in New Orleans the week of July 9, 2008. The grant performance period began April 29, 2008 and ended July 30, 2008.

Funding for this grant is 60% Federal funds passed thru the State of Alaska, Department of Natural Resources, Division of Parks and Outdoor Recreation with a 40% match by the Municipality of Anchorage, Historic Preservation Fund, for a total of \$5,702.
