Appropriation of Two Million One Hundred Twenty-Four Thousand Two Hundred Ninety-Five Dollars (\$2,124,295) from the Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management and contribution of Eighty-Two Thousand Seven Hundred Twenty-One Dollars (\$82,721) from Anchorage Areawide Operating fund (101) Municipal Manager Department, Office of Emergency Management 2008 Operating Budget to the Areawide General CIP Fund (401) for support of Public Safety Interoperable Communications (PSIC) Grant activities in the Municipal Manager Department, Office of Emergency Management

The Municipality of Anchorage, Office of Emergency Management has received a grant from the U.S. Department of Commerce and U.S. Department of Homeland Security through the State of Alaska to fund Interoperable Radio Equipment Training and Exercises for the Anchorage Wide Area Radio Network (AWARN) system. Appropriation of this grant is requested to the Areawide General CIP Fund (401).

The grant funds will be used to purchase portable radios for the Anchorage Police Department, Anchorage Fire Department, Anchorage Police Department Auxillary Search Team, Chugiak Volunteer Fire Department, Girdwood Volunteer Fire Department and mobile radios for the Girdwood Fire Department.

The funds will also be used to provide vendor specific technology training and to conduct all hazards exercises integrating interoperable communications.

The AWARN system is a multi-year, phased project that includes equipment, training, project management and infrastructure. Currently the project is 59% complete.

State Homeland Security Program Grant funds will be administered by the Municipality of Anchorage Office of Emergency Management.

Grant performance period is September 15, 2008 through March 31, 2010.
