**SUBJECT:** A Resolution of the Municipality of Anchorage Providing for Revisions to the 2008 General Government Operating Budget to Provide 2008 Appropriations Commensurate with 2008 Expenditure Projections for Various Departments and Funds.

The 2008 General Government Operating budget needs to be amended by \$1,826,185 to accommodate the budget deficit in the Anchorage Fire Department and cover the cost of the Taxicab Permit Ballot Proposition settlement.

The Anchorage Fire Department (AFD) will close 2008 with an estimated projected budget deficit of \$1.7 million. The shortfall can be attributed to a number of factors: \$1.4 million in labor. Factors contributing to this include 1) the Firefighter Academy incurring non-budgeted overtime. 2) A unusually high number of long term absences due to sick leave at the senior officer levels, 3) Paternity leave for 25 babies. In non-labor, \$300,000 in increases in freight/supply costs for contracts related to equipment, supplies, personal protective gear, the CSP contract, and implementing new emergency medical technology which increased patient survivability.

The Chief Fiscal Officer (CFO) Department budget requires an appropriation of \$126,185 to cover the cost of the Taxicab Permit ballot proposition settlement. This cost will be included for recovery in the 2009 Tax Cap calculation at 1<sup>st</sup> Qtr of 2009.

The budget increases suggested to implement the supplemental appropriations are:
