12 Fund (261), for the Community Read Program.



SUBJECT: APPROPRIATION OF A DONATION OF TWENTY THOUSAND DOLLARS (\$20,000) FROM TARGET CORPORATION TO THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT, MISCELLANEOUS OPERATIONAL GRANTS (261), FOR THE COMMUNITY READ PROGRAM 2009

Target Corporation has partnered with the Anchorage Public Library for the Community Read Program. This program will be implemented in two parts, the first to start in February, 2009, the second in June, 2009.

The community read program will encourage families to read together; the books will center on the theme of being Alaskan. The winter program will be in conjunction with Iditarod, the 50th anniversary of Alaska's statehood and the theme of University of Alaska/Alaska Pacific University's books of the year, "Alaska Natives: A Call for Understanding." The theme for the summer reading program is "Be Creative @ Your Library."
