8 **THE ANCHORAGE ASSEMBLY RESOLVES:**



16 State Categorical Grants Fund (231) to maintain the Municipality's oil spill response capabilities.



Subject: A resolution of the Municipality of Anchorage appropriating \$10,000 received from the Alaska Department of Environmental Conservation (ADEC) and \$220, as a contribution from the Anchorage Fire Department 2008 Operating Budget, to maintain the Municipality's oil spill response capabilities

The aforementioned grant award will be administered under a Memorandum of Understanding (MOU) executed with the ADEC. The MOU provides for the state-funded continued contract maintenance of equipment purchased to enhance the Municipality's oil spill response capabilities in conjunction with similar efforts being undertaken by ADEC on a statewide basis. In that no state funds are provided to cover the Municipality's estimated charges associated with administering the award, the requested resolution includes an appropriation of a \$220 contribution from the Anchorage Fire Department's 2008 Operating Budget to cover these costs.
