

THE ANCHORAGE ASSEMBLY RESOLVES:



This resolution appropriates One Hundred Ninety-Nine Thousand Dollars (\$199,000) from the Southcentral Foundation to the Federal Grants Fund (241) to partially fund the Emergency Alcohol Services Program, Community Services Patrol contract administered by the Anchorage Fire Department. This contract currently provides public inebriate pick-up and monitored sleep-off services.

The department received final notification of this 2008 continuation funding grant award in mid-November. The requested appropriation provides partial funding to complete the 2008 contract year which ends on December 31, 2008.
