- care and control center shall be spaved or neutered [PRIOR TO TRANSFER OF OWNERSHIP OF THE ANIMAL TO THE ADOPTING OWNER] except if, in the determination of a licensed veterinarian. a medical delay is required due to the health or age of the animal. , EXCEPT IF, IN THE DETERMINATION OF A LICENSED VETERINARIAN, A MEDICAL DELAY IS REQUIRED DUE TO THE HEALTH OR AGE OF THE ANIMAL.]. The chief animal control officer shall establish procedures to accomplish spay/neuter, either at the animal care and control center, or through arrangements with the local veterinary community and establish an appropriate fee structure, using customary market prices for such medical services in order to implement this section.
  - Any person who adopts a dog or cat that is not [TOO YOUNG 1. TO BE] spayed or neutered at the time of adoption, shall agree in writing to have the animal spayed or neutered [STERILIZED] by a date specified. The date specified for sterilization may be altered upon the written recommendation of a licensed veterinarian. Proof of sterilization shall be submitted to the animal care and control center upon completion. The person adopting the animal shall provide for the expense of the required sterilization.

### Animal care and control fee schedule. 17.70.010

The chief animal control officer shall provide for collection and Α. disbursement of the following fees and refunds in the administration of Title 17:

5. Adoption: \*\*\* \*\*\* c. If the animal is not spayed or neutered at the time of adoption, the chief animal control officer may require [A WAITING PERIOD HAS BEEN ESTABLISHED.] a deposit equal to the cost of the sterilization [SHALL] to be made at the time of the adoption, to be refunded within 30 days following presentation of proof of sterilization to the animal care and control center. Proof of sterilization must be in the form of a signed document from a licensed veterinarian.

**DEPOSITS.** 

Spaying and neutering dogs and cats is an important part of responsible pet health care and an essential component in humanely decreasing animal overpopulation and the euthanasia of homeless pets in animal shelters.

The Anchorage Animal Care and Control Center (AACCC) strategic plan calls for reducing the number of animals received at the shelter. Promoting spaying and neutering is critical in fostering this important objective.

Since 2003, unsterilized dogs and cats adopted from AACCC were transported to local clinics for spaying or neutering prior to going home with their adoptive families.

The contract for sterilization services included options to renew through 2009. However, the contractor elected not to renew their contract and it expired January 31, 2009. Efforts to gain a new contractor for these services, including issuance of an invitation to bid and numerous meetings and discussions with potential providers, were unsuccessful. No clinics are capable of or interested in partnering with the municipality to accomplish the required surgeries.

Before spaying/neutering pets prior to adoption began in 2003, adopters paid a refundable spay/neuter deposit at the time of adoption. Pet owners then had 30 days to complete the surgery and show evidence of the sterilization. Either a refund was issued upon compliance or a citation and fine for non-compliance.

This refundable spay/neuter deposit system requires reinstating since there is not a spay/neuter vendor in place. A code change is required in order to make that possible.

Taking a spay/neuter deposit is seen as a method to continue the AACCC adoption program while the municipal administration explores alternative methods

to ensure all pets adopted from AACCC are spayed or neutered. Staff is currently researching placement of an on-site spay/neuter clinic which would provide a permanent solution for the AACCC program.
