AN ORDINANCE SUBMITTING A BALLOT PROPOSITION TO THE QUALIFIED VOTERS OF THE MUNICIPALITY OF ANCHORAGE AT THE REGULAR MUNICIPAL ELECTION OF APRIL 6, 2010, TO AMEND THE ANCHORAGE MUNICIPAL CHARTER ARTICLE II, BILL OF RIGHTS, PARAGRAPH (7), TO EXPAND THE RIGHTS GUARANTEED TO THE PEOPLE OF ANCHORAGE BY PROHIBITING DISCRIMINATION BASED UPON SEXUAL ORIENTATION.

THE ANCHORAGE ASSEMBLY ORDAINS:

Shall Anchorage Municipal Charter Article II, Bill of Rights, Paragraph (7) be amended to read:

ARTICLE II BILL OF RIGHTS.

This Charter guarantees rights to the people of Anchorage that are in addition to rights guaranteed by the Constitution of the United States of America and the Constitution of the State of Alaska. Among rights guaranteed by this Charter are:

(7) The right to opportunities in housing, public accommodations, employment, and education without regard to race, religion, sex, color, national origin, marital status, **sexual orientation**, or physical disability;
