20 **Section 1.** The fiscal year 2010 Operating and Capital Improvement Budgets of the
21 Anchorage Community Development Authority (ACDA) are hereby adopted.

7 The Anchorage Assembly adopted Anchorage Ordinance 2004-181(S) as
8 amended, on January 18, 2005, establishing the Anchorage Community
9 Development Authority. The ACDA expanded the role of the former Anchorage
10 Parking Authority into a development and parking authority, with parking operations
11 now a unit within ACDA.
12

13 ACDA works in partnerships with neighborhood residents, business owners,
14 community-based organizations and developers to provide a clear and integrated
15 approach to economic investment that addresses the current and future needs of
16 the City.

18 The 2010 operating and capital budgets for the Anchorage Community
19 Development Authority were reviewed and approved by the Anchorage Community
20 Development Authority Board.
