

Subject: A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SEVEN HUNDRED FIFTY THOUSAND DOLLARS (\$750,000) FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE ON VIOLENCE AGAINST WOMEN, TO THE FEDERAL CATEGORICAL GRANTS FUND (241) TO PROVIDE DOMESTIC VIOLENCE PREVENTION SERVICES IN THE DEPARTMENT OF HEALTH AND

HUMAN SERVICES.

This appropriation will provide the funding necessary to provide Domestic Violence Prevention Services through the Department of Health and Human Services. The period of this grant is from September 1, 2008 through August 31, 2010.

This project will support collaboration with the Multi-Agency Justice Integration Consortium (MAJIC) to expand the ADVPP II's successful data management information system statewide and provide current conditions of release, judgments and protective orders for defendants in all domestic violence cases. This project will fund a 1.0 FTE Project Manager at DHHS to coordinate efforts with MAJIC, to help design electronic data sharing and to analyze data to assess impacts of arrests, warrant service, prosecution and court compliance to increase offender accountability. A 1.0 FTE Legal Clerk at the Municipal Department of Law, Prosecutor's Office, will assist with data collection, integration and data field design. Abused Women's Aid In Crisis (AWAIC) will provide victims with assessment, information and referrals, as well as emergency financial aid for items such as safe housing, transportation, medical care and food.
