1 A RESOLUTION ADOPTING THE 2009 LEGISLATIVE PROGRAM FOR THE MUNICIPALITY
2 OF ANCHORAGE.

4 WHEREAS, the Acting Mayor of the Municipality of Anchorage, the Anchorage Assembly, the
5 Anchorage School District and the University of Alaska Anchorage are unified in their support
6 of state legislation and budgetary items for the Municipality of Anchorage; and

8 WHEREAS, with nearly half the state's population, Anchorage is the business and
9 transportation hub for Alaska, and what happens in Anchorage affects much of the rest of
10 Alaska, from expansion of the Port of Anchorage to construction of a new "Highway to
11 Highway" transportation connection; and

13 WHEREAS, Anchorage recognizes its dominant role in Alaska's well being and our citizens
14 have invested millions of dollars in our city through local taxes to improve it for all Alaskans;

17 WHEREAS, Anchorage is grateful to our state legislative delegation and Alaska's
18 congressional delegation for millions of dollars in assistance, which we have leveraged to
19 match local investments in improving transportation, commerce, public buildings, roads, and
20 parks and recreational facilities; and

22 WHEREAS, Anchorage's infrastructure needs still remain considerable, with congested roads,
23 deteriorating public facilities and population growth requiring additional public services; and
24

25 WHEREAS, Anchorage's 2009 capital budget needs have been identified through work with
26 community councils, members of the Assembly and discussions with our state legislators; and

28 WHEREAS, the Municipality of Anchorage has developed a legislative program, now,
29 therefore;
