A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS TEMPORARY NON-OBJECTION TO APPLICATION OF A NEW GENERAL WHOLESALE LIQUOR LICENSE, SOUTHERN-ODOM WINE AND SPIRITS OF ALASKA, LLC LICENSE #4861, D/B/A SOUTHERN-ODOM WINE AND SPIRITS OF ALASKA LOCATED AT 1800 SHIP AVENUE, ANCHORAGE, ALASKA 99501.

WHEREAS, Southern-Odom Wine and Spirits of Alaska, 1600 NW 163rd Street Miami, Florida 33169, d/b/a Southern-Odom Wine and Spirits of Alaska, located at 1800 Ship Avenue Anchorage, Alaska 99501, has made application and paid the required fee for a New General Wholesale License #4861 with the Alcoholic Beverage Control Board; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on December 26, 2008, and has determined that the last day for the Assembly to protest transfer of General Wholesale License #4861 is February 24, 2009; and

WHEREAS, the requisite research and Assembly protest review process will proceed and this matter will be scheduled for public hearing; and

WHEREAS, the owners of Southern Odom Wine and Spirits wish to close business transactions in a timely matter for General Wholesale License #4861, prior to public hearing before the Assembly and elapse of the sixty-day protest deadline;


NOW, THEREFORE, the Anchorage Assembly RESOLVES:

Section 1. The Anchorage Assembly hereby states its temporary non-objection to new General Wholesale License 4861; and

Section 2. The Anchorage Assembly hereby reserves final action on the application until public hearing is completed, within the protest period. This temporary non-objection shall not be used to bind the Assembly to any future action of this liquor license, including without limitation, final action by the Assembly on the application for new General Wholesale License within the protest period.

Section 3. A copy of this resolution may be presented to the Alcoholic Beverage Control Board as proof that the Anchorage Assembly, as the local governing body, has stated its temporary non-objection to new General Wholesale License #4861, in order to permit the Director of the Alcoholic Beverage Control Board to issue temporary approval of the license.
