The attached Resolution appropriates \$3,037,350 of BP2009 tax revenues as a contribution from CBERRRSA Fund 119 approved in the BP2009 General Government Operating Budget to CBERRRSA Capital Improvement Project Fund 419 for road and drainage capital improvement projects. On October 1, 1991 voters approved the CBERRRSA Capital Improvement mill levy of 1.00 mill. The total 2009 CBERRRSA Capital Improvement Program mill levy is approved in the 2009 Operating Budget in the amount of \$3,037,350. The final BP2009 CBERRRSA Capital Improvement mill levy is set during the first quarter budget revision and is subject to Assembly approval and tax revenue collections.

As the mill levy for CBERRRSA is collected, that portion designated for the CBERRRSA Capital Improvement Program is transferred as a contribution to CBERRRSA Capital Improvement Project Fund 419. Transfers from CBERRRSA Fund 119 at no time shall exceed the pro-rata share of the collected mill levy designated for the CBERRRSA Capital Improvement Program.
