

11 THE ANCHORAGE ASSEMBLY RESOLVES:

13 Section 1. That THIRTY-ONE THOUSAND ONE HUNDRED SIXTY-THREE DOLLARS
14 (\$31,163) is appropriated as a grant from the State of Alaska, Department of Military and Veterans
15 Affairs, Division of Homeland Security and Emergency Management to the State Categorical Grants
16 Fund (231), Anchorage Police Department, to purchase terrorism response and prevention equipment.



18 Section 2. That ONE THOUSAND TWO HUNDRED NINE DOLLARS (\$1,209) is appropriated
19 from the 2009 Anchorage Police Operating Budget, Anchorage Metropolitan Police Service Area Fund
20 (151) as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department, to
21 purchase terrorism response and prevention equipment.

Subject: Appropriation of State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management State Homeland Security Reallocated FY2007 Law Enforcement Terrorism Prevention Program Grant Funding (\$32,372)

The Municipality of Anchorage, Anchorage Police Department (APD) has received from the Office for Domestic Preparedness through the State of Alaska, FY2007 Reallocated LETPP Grant funding to enhance security and preparedness for terrorist prevention. Appropriation of grant and required local matching funds is requested to the State Categorical Grants Fund (231).

Grant funds awarded provide for the procurement of additional specialized terrorism response personal protective equipment to be utilized by APD.

FY2007 Reallocated Law Enforcement Terrorism Prevention Program Grant funds will be administered by the APD. A special condition of this grant is that the department contribute funds to support associated indirect grant costs. The total projected municipal cost is \$1,209 which is funded through a 2009 operating contribution from the Anchorage Metropolitan Police Service Area Fund (151). This grant began on October 1, 2007 and will end on September 30, 2009.
