12 Section 1. That FIFTY-FIVE THOUSAND FOUR HUNDRED TWENTY-EIGHT
13 DOLLARS (\$55,428), is appropriated from the State of Alaska, Department of Transportation &
14 Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department for
15 Seat Belt Enforcement.

17 Section 2. That TWO THOUSAND ONE HUNDRED FIFTY-FIVE DOLLARS (\$2,155) is
18 appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2009 Anchorage
19 Police Department Operating Budget as a contribution to the State Categorical Grants Fund
20 (231), Anchorage Police Department.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Seat Belt Enforcement Program Grant and local match required (\$57,583)

The Municipality of Anchorage has received a \$55,428 grant from the State of Alaska, Department of Transportation & Public Facilities for a Seat Belt Enforcement program. This grant will support focused enforcement during January 1, 2009 through March 31, 2009.

This grant will pay officer overtime for traffic assignments specifically targeted for enforcement of seat belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of seat belt driving offenses, Anchorage citizens will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$2,155, which has been budgeted in the 2009 Police Operating Budget. This grant, which is being presented after the actual start date due to late notification by the grantor, began on January 1, 2009 and will end on March 31, 2009.
