Department \$270,000

The Anchorage Police Department requests appropriation of TWO HUNDRED SEVENTY THOUSAND DOLLARS (\$270,000) to the Police Investigation Fund (257). This sum is from seized and forfeited monies that have been awarded to the Anchorage Police Department by the U.S. Drug Enforcement Agency (DEA) through state and federal judicial proceedings as a result of joint DEA and Anchorage Police narcotics interdiction operations.

The United States Attorney General is authorized under asset forfeiture provisions of the Comprehensive Crime Control Act of 1984, the Anti-Drug Abuse Act of 1986, Title 21 of the United States Code, and the Tariff Act of 1930 to transfer forfeited property. The transfer must be to local law enforcement agencies that participate directly in seizure or forfeiture of the property. The Attorney General exercises final authority over the official retention and transfer of forfeited property to local law enforcement and establishes the guidelines and limitations for its use.
