The Municipality of Anchorage has received a \$139,464 grant from the State of Alaska, Department of Transportation & Public Facilities for a DUI .08 Impaired Driving Enforcement program. This grant will support focused enforcement during January 1, 2009 through March 31, 2009.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of impaired driving violations within the Municipality of Anchorage.
